Sanitation Truck: New truck is expected to be delivered on Schedule.

A roll call vote was taken on each of the motions: (Yes-Moody, Finney, Person, Stapleton, Milligan No - Riley) Motion passed. 2017-0 - Councilperson Milligan made a motion to suspend the rules and have the 1<sup>st</sup> reading title only, 2<sup>nd</sup> by Riley. Mayor Dixon read the Ordinance by title only. A roll call vote was taken on each motion . 6 yes 0 No each vote. Motion passed.
